ORDER:

In the GO 1st read above and as amended in G.Os 3rd and 5th read above, the time up to 31.12.2015 was stipulated for filing applications under the A.P. Regulation and Penalization of unauthorizedly constructed buildings and buildings constructed in deviation of the sanctioned plan rules, 2015.

2. In the reference 6th read above, the Director of Town & Country Planning, Andhra Pradesh, Hyderabad has informed that the implementation of new online system in application procedure, insufficient staff in Municipal Corporation and insufficient number of professional engineers to redraw plans and many other reasons, 50% of the public are not able to utilize the scheme and also stated that due to this extension, all irregular constructions will be regularized and therefore, requested the Government to issue necessary orders to extend time for submission of applications under B.P.S scheme at-least for another one month i.e., up to 31.01.2016.

3. Government after careful consideration of the matter and in exercise of the powers conferred under section 455-AA of the Hyderabad Municipal Corporation Act, 1955, section 218-A of the Andhra Pradesh Municipalities Act, 1965, section 46-A of the Andhra Pradesh Urban Areas (Development) Act, 1975, and section 108A of the Andhra Pradesh Capital Region Development Authority Act, 2014 hereby issue the following amendment to the rules issued in the G.O 1st read above.

AMENDMENT

In rule 3(6) of the said rules, for the words "within 60 days from the Notification of these Rules" the following words shall be substituted namely:

"On or before 31.01.2016"
